King of Prussia District and Upper Merion Township is accepting competitive technical and price proposals from qualified firms or individuals to develop necessary studies, preliminary design, final design, and bid documents for the project, including all necessary agency coordination and permitting. The project will be based upon the 2023 Moore Road Multimodal Trail and Linear Park Study. (<https://visitkop.com/what-we-do/research-publications/>).

The bids must be made as described in the RFP posted at (<https://visitkop.com/what-we-do/rfps-and-district-updates/>) and the bids must be accompanied by all completed documentation requested. The successful bidder shall be bound to meet insurance requirements listed in RFP.

The Bidder's attention is called to the fact that the Pennsylvania Prevailing Wage Act applies to this Contract and that the successful Bidder shall pay no less than the Wage Rates determined for the project area as set forth in the Contract Documents.

The successful bidder shall take affirmative action to ensure that applicants for employment and employees or agents are treated without discrimination by reason of race, gender, creed, color, sexual orientation, gender identity or expression, or in violation of the Pennsylvania Human Relations Act (PHRA) and applicable federal laws, against any citizen of this Commonwealth who is qualified and available to perform the work to which the employment relates.

The Owner reserves the right to reject any and or all submissions and to waive any informality in the bidding, as permitted by law. No bidder may withdraw a bid within ninety (90) days after the actual date of the opening thereof, except in accordance with the terms of PA Act 4 of 1974, latest revision.

Funding for **Professional Services for Moore Road Multimodal Trail** is provided by the Commonwealth of Pennsylvania and the Commonwealth Financing Authority's Local Share Account and Multimodal Transportation Fund. It is anticipated that funding for construction of the Moore Road Trail and Road Diet will be provided by a mix of federal, state, and local grant programs.
